Commissioner Ferron,

We're excited about the upcoming April 24th workshop "Building a More Energy Efficiency Future: A National Perspective" at the Parc 55 Wyhdam hotel, and are pleased that more than 20 Commission staff have signed up to attend. However, we've run into an internal CPUC policy regarding 'gifting' of food which we were not previously aware of. My understanding is that the CPUC can decide to pay for the food of the employees who attend, or if the CPUC does not cover the cost, the employee can either reimburse us for the food or choose not to eat.

The costs for food are estimated to be \$35.09 for breakfast and \$72.60 for lunch per person, plus some potential snack or beverage costs that will not be finalized until a after the event. Would it be possible for the Commission to cover these costs? We would like to let Commission staff know the situation in advance, so they can make an informed choice about whether to eat or not.

Other possible options would be for Commission staff to pre-order food from the Hotel or go to a local restaurant in the area during breaks. We'd like to work with you in whatever fashion would make this best for everyone.
