All Parties to Rulemaking ("R.") 11-05-005:

Pursuant to Rule 16.6 of the California Public Utilities Commission ("CPUC") Rules of Practice and Procedure, Pacific Gas and Electric Company ("PG&E") hereby informs all parties to R. 11-05-005 that the Executive Director of the CPUC authorized an extension of time to comply with Decision ("D.") 12-11-016. The attached letter granting PG&E's April 5, 2013 extension request specifies that both PG&E and San Diego Gas and Electric Company ("SDG&E") must adhere to the extension dates identified in PG&E's request.

PG&E's extension request concerned the 2012 Renewables Portfolio Standard ("RPS") Request for Offers ("RFO") milestones established by Ordering Paragraph 19 of D. 12-11-016. The extended milestones dates applicable to PG&E and SDG&E are summarized below and are also established in the attached letter from the Executive Director granting PG&E's request.
