Part of the problem on our end was that the request bounced around to the wrong individuals and there was no clear accountability for handling the request because it was not part of a proceeding. On a going forward basis, we would appreciate it if Energy Division could please send all PG&E **ad hoc** (i.e., requests not related to a specific proceeding) **energy supply data requests** to Sujata Pagedar (SXPG@pge.com, 415-973-9801).
