Attached to this email, please find PDF electronic versions of DRA's testimony in response to Pacific Gas and Electric Company's 2014 General Rate Case application. DRA recommends a \$162 million (or 2.4%) decrease in revenues for the 2014 test year, compared to PG&E's request for a \$1.28 billion (18.8%) increase.
