Subject: All Party Questions for LIOB Meeting on May 16

At the upcoming LIOB meeting on May 16, Commissioner Sandoval will conduct an All-Party meeting in the afternoon pertaining to "Items 10) "CARE Categorical Enrollment-CPUC Staff" and "11) ICF International Q and A." The Joint Utilities Advice Letter 4457 CARE was denied without prejudice, and the issues raised in the application will be explored through an upcoming Assigned Commissioner's Ruling (ACR) that will solicit comments and reply comments about determination of CARE eligibility. This ACR will create a record to inform the CARE Eligibility Guidance Proposed Decision. The purpose of this All-Party is to discuss whether these are the appropriate questions to ask for the ACR to solicit comments, briefs, and to build the record. This discussion is not intended to provide substantive answers to or discussions of the questions, but to discuss whether these are the correct questions to ask in the ACR.
