Richard

We have answers.

1. Yes, it would require a security guard. We don't know of any other measures that would be required, but we wouldn't support putting a security guard at the facility.

2. As for frequency of use, we don't know. What we DO know is that about 100 people were issued cards over the last 10+ years, and that's for our entire system. I would guess that less than 5 have used the San Ramon facility after hours.

And here's some more background from our Corporate Security folks:

This issue surfaced to Corporate Security last year when some of the access cards became deactivated. This was the first time it brought to our attention that we had citizens entering our yards after normal business hours. Realizing the safety and security issue, I asked who in Corporate Security authorized this to occur. No one in Corporate Security approved this type of access or were involved in the process that I can identify. There was no correspondence provided to identify a policy or decision to allow this practice so there is no policy change.

Corporate Security conferred with Legal and determined that there were liability and safety/security issues and that the practice needed to end. Letters about the change were sent to the customers we were able to identify.

Let me know if we can provide any additional information. As you can tell, we don't have much more detail to provide.
