No. PSEP is transmission only, as directed by the Commission.

Distribution costs are in our "general rate case" -- and there is one of those before the Comm right now. We have been spending more on distribution safety than was authorized by the Comm in our last general rate case. Shareholders have to pick up those additional costs.

Transmission costs are typically (ie, in the days before San bruno and PSEP) put forward in our "gas transmission and storage (GT&S)" rate case. That is also known as "Gas Accord V" in table 1 of our May 16 response to you.

I know its confusing and I don't know why its broken out like this, except precedent. Our gas transmission rate cases were known as "gas accords" because parties were mostly able to settle on the big issues and bring that to the cpuc. I doubt we will see that again for a while ...
