May or early June

Folks,

Thanks for your presentations in the first two workshops, that focused on human health and safety. ARB/OEHHA found your feedback valuable. They are now busy wrapping up their May 15 report and are incorporating the feedback you provided them.

At Workshop 2 in Sacramento, there was significant interest in holding a third workshop, this time focusing on pipeline safety. Due to that interest, we are now planning to hold a third workshop, at the 505 Van Ness CPUC building in San Francisco.

At the third workshop, we would like a joint utility presentation (if possible; else separate presentations) about pipeline safety and integrity at the workshop, which may also include presentations from other stakeholders. We're thinking end of May or early June, with the supplemental testimony deadline being moved to the end of June or later; the supplemental testimony will incorporate human AND pipeline safety. The third workshop will serve as a forum for discussion of pipeline safety in advance of the supplemental and rebuttal testimony. This third workshop will be a chance to fine-tune what will be filed as supplemental testimony.

To address any questions about this, including finalizing a date for Workshop 3 (we will try to avoid Memorial Day weekend and the day immediately before and after), I'm going to set up a

conference call for next Tuesday.

Please let me know if you prefer 11 am, 2:30 pm, 3pm, 3:30pm, 4pm, or 4:30 pm. The call shouldn't be longer than 30 minutes. Please feel free to forward this to anyone I missed in your organization that should be on this call.

As a final note, only CPUC staff and utilities will be on this call, as I'll be in touch with other stakeholders separately.
