PG&E has drafted the attached letters for Energy Division's review pursuant to Ordering Paragraph 4 of D.10-11-011 which states: "Pacific Gas and Electric Company (PG&E) must promptly send a letter to New Municipal Departing Load customers served by the Modesto Irrigation District and the Merced Irrigation District informing them of the termination of PG&E's billing and collections obligations to New Municipal Departing Load customers served by the Districts. PG&E must provide a draft of the letter to the Director of the Commission's Energy Division for review and approval prior to distribution."

Could you please let me know if you have any suggested changes to these draft letters? Is there anyone else in Energy Division who we should send these letters to for review to comply with this order?
