Good morning,

We wanted to let you know before it is made public that PG&E is in the process of negotiating with the City of Hercules for the purchase of its electric assets. Hercules Municipal Utility, which is owned by the City of Hercules serves approximately 800 customers. PG&E submitted a bid in January in response to the City's request for proposals for the purchase of these assets and was selected as the winning bid. The City wishes to issue a joint public statement soon that would disclose the selection of PG&E's winning bid.

We are now in the process of conducting due diligence and confidential negotiations for a purchase agreement with the City. Assuming that we reach an agreement with the City, PG&E will be filing a section 854 application for Commission approval. Please let Redacted
