ALJ Darling, Mr. Colvin, Mr. Randolph and Ms. Walker,

The tour of Humboldt Bay Unit 3 is confirmed for Friday, June 7. The tour will begin at 7:30AM and end around noon. We will meet all of the tour attendees at the entrance gate to the Plant at 7:30AM. I recommend that you either fly or drive up the day before. I also recommend staying in Eureka, which is just a few miles north of the Plant.

Flying

If you choose to fly, you'll fly into Arcata Airport which is 20 minutes north of Eureka. I recommend taking a flight during the middle of the day. June is a very foggy time of year in Humboldt County and early morning and evening flights are often delayed and sometimes cancelled due to low visibility. United (the only commercial carrier that flies to Arcata) offers several afternoon flights to Arcata, which depart SFO at noon and 2PM on Thursday (6/6). United offers several mid to late afternoon flights from Arcata to SFO that depart at 2:30PM and 4:15PM on Friday(6/7). There are no direct flights from Oakland to Arcata. Arcata Airport has several car rental agencies.

Driving

If you choose to drive, I recommend leaving the Bay Area before 2PM as the roads are not well lit during the evening.

Other Attendees

In addition to myself Redacted and John Hughes, Matt Friedman and Bruce Lacy from TURN will also attend the tour. The DRA will tour Humboldt Unit 3 in late-May.

I will send instructions on what to wear and an itinerary one week before the tour.
