TURN supports the request of Vote Solar for an extension of time for opening comments. TURN is also amenable to an extension of the deadline for the IOUs to file additional information relating to the bill impacts of their rate proposals.

However, it would be unreasonable to have the IOUs provide this information only four days before parties are expected to provide comments. It would be far more appropriate to preserve the current 10-day gap between the provision of additional information by the IOUs and the submission of opening comments by parties. Therefore, TURN supports allowing the IOUs to provide their additional information on July 2 with opening comments due on July 12.

PG&E, SCE and SDG&E support Vote Solar et al's request for an extension of time for opening comments in this proceeding from July 1, to July 12, provided also that the June 21 deadline in the ALJ's June 13 Ruling for the IOUs to file their "Response to ALJ's Request for Additional Information" and to serve an "Illustrative Rate Summary Form" is extended from June 21 to July 8. The "Illustrative Rate Summary Form" and related rate design and bill impacts require additional work and internal analysis that was not assumed to be required when the IOUs prepared their rate design proposals, and were not expressly required in the March 19 ALJ Ruling requesting rate design proposals. In addition, as the ALJ Ruling noted, the use of the bill calculators is a "complex and time consuming endeavor." Given the time frame and other deliverables in the proceeding, the IOUs believe a two week extension of time is reasonable for providing this supplemental information. In the meantime, the IOUs will be providing presentations on their rate design proposals at the June 25 CPUC workshop, and are responding to data requests by other parties. We do not propose any change to the June 21 deadline for service of parties' "Proposal Summary Forms."

## Rate Design proposals

Dear ALJ McKinney:

On behalf of Vote Solar and the parties listed below, we respectfully request that the date for filing comments on the parties' residential rate design proposals be extended from July 1 to July 12. We believe that an extension of time is warranted for several reasons (other than the rescheduling of the initial workshop).

First, as you noted in your Ruling, few parties provided illustrative rates and bill impacts, making it difficult to determine (and comment upon) the impacts on bills, CARE, distributed generation, etc. that may result from the adoption of their varying rate design proposals. We appreciate that you have asked the parties to provide this information by June 21, but that leaves little time left to incorporate this important information into comments.

Second, with comments due on July 1, there is insufficient time for the parties to send, and more important, receive answers to data requests about other parties' proposals. Not only are we concerned that new information will be provided at the workshop that will require further analysis prior to filing comments, but we expect questions to be raised at the workshop that will require parties to perform and distribute further calculations and information, which likely will not be available in sufficient time for meaningful inclusion in comments due July 1.

Finally, we are hopeful that as parties have a chance to thoroughly review other parties' proposals, and explore those proposals further at the workshop, parties will begin to talk about the possibility of collaborating on revised proposals.

Unfortunately, we expect that with comments due less than a week after the workshop, parties will be forced to focus all their attention on preparing comments supporting their own specific proposals rather than discussing more collaborative, revised proposals with other parties.

For all these reasons, we respectfully request that the comment period be extended from July 1 to July 12.

As required by Rule 11.6, I contacted all the parties to this proceeding (by email) to determine their support for this proposal. The following parties expressed support: Vote Solar, SEIA, Sierra Club, EDF, TURN, DRA, IREC and CforAT. The following parties stated they did not oppose the request: CLECA, MEA, CCSE, SDCAN and Greenlining. I did not receive any response from PG&E, SCE or SDG&E or any of the other parties.
