Energy Division staff request information from Pacific Gas and Electric Company (PG&E), Southern California Edison Company (SCE) and San Diego Gas & Electric Company (SDG&E) regarding electricity customers that are in industrial sectors designated as "emissions intensive and trade exposed" (EITE) by Decision (D).12-12-033, as well as limitations of displaying text on customer bills.

For the purposes of this data request, EITE industries (or "EITE NAICS codes") are those industries designated by the NAICS codes listed in Table 8-1 of the Air Resources Board's Cap and Trade Regulation.<sup>1</sup>

## Question 1

Please indicate the maximum character length (characters plus spaces) of text that can be displayed on customer electricity bills as a title or description of line-item bill credits. For example, if an industrial customer were to receive a bill credit as authorized in D.12-12-033, what is the maximum text length of the name of this bill credit that could be displayed on a customer bill? If this character length differs for electronic versus paper bills, please also indicate the maximum character length for electronic bills.

## Question 2

Please provide in Excel table form the following information for electricity customers. For each unique customer facility (i.e. unique physical premise or site) that is associated with one of the eligible EITE NAICS codes, provide the following:

- A unique identifier for this facility in the utility's billing system (i.e. an identifier uniquely associated with this facility). Explain what type of identifier is used.
- Business name associated with this facility.
- Facility zip code
- 6-digit NAICS code associated with this facility. If a 6-digit code is unavailable, provide a 5-digit code or a 4-digit code.
- The NAICS code title for this facility.
- Total bundled kWh of electricity purchased by this facility in 2012.
- Total unbundled kWh of electricity purchased by this facility in 2012.
- Indicate True/False whether this facility would have met the definition of small business in 2012 (as defined in D.12-12-033), taking into consideration the twelve months bound by Jan 1, 2012 and December 31, 2012 (i.e. Evaluate whether the facility would qualify as a small business if the evaluation were being performed on December 31, 2012.)
- If known, indicate True/False whether this facility is a Covered Entity under ARB's Cap and Trade program.
