**NOTICE OF NEW AUTHORITY**

The City and County of San Francisco (San Francisco) respectfully files this Notice of New Authority with respect to its reply brief, filed on June 7, 2013. San Francisco learned that a case cited in its reply brief, *Horne v. United States Department of Agriculture* (9th Cir. 2011) 673 F.3d 1071, was overturned yesterday by the United States Supreme Court in *Horne v. United States Department of Agriculture*, 569 U. S. \_\_\_\_ (2013). The Supreme Court opinion is attached. The case was overturned on grounds other than those for which it was cited. San Francisco cited the case with respect to the constitutionality of the fines imposed under the

Eighth Amendment's ban against excessive fines. The Supreme Court did not address this issue in its opinion.
