Subject: R.12-06-013 IREC's Statement re: Rate Proposal Summaries

Dear Parties to R.12-06-013,

The Interstate Renewable Energy Council, Inc. (IREC) submitted comments on May 29, 2013

that included a CleanCARE proposal that could complement a wide variety of rate designs, but is not a comprehensive rate design proposal itself. After discussions with ALJ McKinney, it was determined that the limited scope of our proposal puts IREC outside of the scope of the request for supplemental information and illustrative rates, and there was no need for IREC to supplement its May 29, 2013 filing. In addition to the CleanCARE proposal, IREC's filing reiterated that our primary purpose in this proceeding is to provide expert analysis of parties' rate proposals to ensure that the impacts on net metering customers will be effectively modeled. We believe this part of IREC's effort is not a rate proposal either, and, therefore, did not require a supplemental filing. We look forward to continuing to work with all stakeholders in the docket.
