Response: New procedure TD-4199P-01, "Procedure for the Resolution of Unknown Pipeline Features (PRUPF)" is currently going through review and is expected to be issued in July 2013. A draft of this procedure was provided to Sunil Shori in an email from Frances Yee, dated May 7, 2013, and is provided again for reference.
