- 4) Schedule standing time for phone calls for updates.

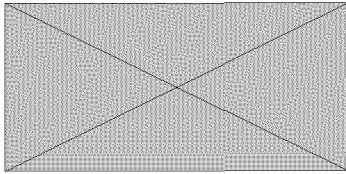
Seems we ought to be able to do this in 45 minutes or so.
