Pursuant to Rule 8.4(a) of the Commission's Rules of Practice and Procedure, Pacific Gas and Electric Company (PG&E) hereby gives notice of the following ex parte communication. The communication occurred on Monday, July 22, 2013, at approximately 3:30 p.m. at the offices of the California Public Utilities Commission. Sidney Dietz, Director, Regulatory Relations, PG&E, initiated the communication with Scott Murtishaw, Advisor to Commission President Michael Peevey. Present for PG&E were: Sujata Pagedar, Director, Energy Supply Proceedings, and Donna Barry, Principal, Energy Supply Proceedings. Present from the CPUC's Energy Division were: Electric Market Structure and Design - Jonathan Tom, Supervisor, Kathryn Auriemma, Regulatory Analyst, and William Maguire, Regulatory Analyst; Retail Rate Design - Paul Phillips, Supervisor, and Michelle Kito, Regulatory Analyst. Mr. Dietz stated that the issues around non-bypassable charges have been litigated sufficiently, and do not require a new OIR. Ms. Barry and Ms. Pagedar described the different

types of non-bypassable charges, including CTC, PCIA, and CAM. Ms. Pagedar stated that these charges represent the outcome of recent litigation and are consistent with legislation.
