I. INTRODUCTION

Pursuant to Rules 1.4(b) and 11.1 of the California Public Utilities Commission’s (Commission) Rules of Practice and Procedure, the Silicon Valley Leadership Group respectfully moves for party status in the above captioned proceeding.

II. BASIS FOR PARTY STATUS

A. Background Silicon Valley Leadership Group.

The Silicon Valley Leadership Group (“Leadership Group”) was founded in 1978 by David Packard of Hewlett-Packard and represents more than 375 of Silicon Valley's most respected employers on issues, programs and campaigns that affect the economic health and quality of life in Silicon Valley, including energy, transportation, education, housing, health care, tax policies, economic vitality and the environment.
