On July 8, 2013 the Consumer Protection and Safety Division (now named the Safety and Enforcement Division) filed its motion for procedural rulings to govern these proceedings. Among other things, CPSD requests leave to file an Amended Reply Brief in the Fines and Remedies Phase by Monday, July 15, 2013.

For this to be possible, CPSD also requests that the time for responses to this procedural motion be shortened to 5:00 p. m. on Wednesday, July 10, 2013, so that the ALJs can rule prior to Monday, July 15, 2013 when CPSD proposes that its 10-page Amended Reply Brief would be due. For good cause shown, the time for responses to CPSD's request to file an amended reply brief is
