Subject: AB 327 amendments

Attached please find a copy of the amendments for AB 327 (Perea) which was put across the desk today. The amendments reflect the committee's action yesterday and replace all content in the bill so you have the full text as it will appear in print. The bill will not be in print until next week, possibly as late as Tuesday or Wednesday, due to the nuances of the legislative process nuances. This document has been provided to Assemblyman Perea's office and to the Governor's staff. It is public so feel free to distribute further.

I understand that the ratepayer groups and IOUs are continuing to discuss further revisions. Obviously negotiation of this bill is about to move into a larger group, likely led by the Governor's office, which will make it difficult to further amend the bill later this summer. I think that you need to conclude your work by Monday at the latest. The Senate recesses next Thursday until August 12th. Assuming that Assemblyman Perea is in agreement -- if you provide further amendments to me on Monday, I might be able to work with Appropriations Committee and get the bill amended before we adjourn which will give you a final work product, in print, for our summer recess and a launch pad for review and discussion with the Governor's office and other stakeholders.
