Subject: I. 12-01-007 - PG&E Gas Pipeline Investigations - Ruling Shortening Time to Respond to PG&E Motion and Suspending Briefing Schedule

Notice to All Parties:

On July 18, 2013, PG&E filed *Pacific Gas And Electric Company's Motion To Reopen Evidentiary Record In The Coordinated Penalty Phase; Request For Order Shortening Time For Response And Vacating Briefing Schedule Established In July 12, 2013 Email Ruling*. In its motion, PG&E states that the July 16 Amended Reply Brief filed by CPSD presents a new penalty proposal which relies on different law and different purported facts than CPSD's prior proposal. PG&E therefore requests that it be allowed to present new evidence to respond to this new proposal, that the page limits established in the July 12 ALJ email ruling be lifted, and that the time to respond to CPSD's amended reply brief be extended. PG&E further requests that the time to respond to its motion be shortened. So that we may address PG&E's motion, we shall suspend the briefing schedule established in the July 12 email ruling. Additionally, we shorten the time to respond to this motion to July 26, 2013.
