The detailed description of the variance and the subject switch location are included in the revised variance request submitted on July 3, 2013, and in Attachment A to the variance request. Note that Variance No. 39 is conditioned upon the understanding that all applicable IS/MND applicant proposed measures, mitigation measures, and all permit requirements are implemented as appropriate.
