Here's what I know from a supervisor in Sacramento:

It was a third-party (ie., not PG&E) contractor dig-in. 2" distribution pipe. The area had appropriate USA marks, so it appears to have been completely the fault of the contractor.

Gas was shut off at around 11:25 am. 4 news trucks onsite.

This was reported to the CPUC.

Service should be restored this afternoon.

I'll provide more details when I get them.
