Dear Administrative Law Judge Simon,

Pursuant to Rule 11.6 of the California Public Utilities Commission (“Commission”) Rules of Practice and Procedure, the Alliance for Retail Energy Markets, Bear Valley Electric Service, a division of Golden State Water Company, Constellation NewEnergy, Inc., Direct Energy Services, LLC, Noble Americas Energy Solutions LLC, Pacific Gas and Electric Company, PacifiCorp, San Diego Gas & Electric Company, Shell Energy North America (US), L.P., Southern California Edison Company, and the Western Power Trading Forum (collectively the “Joint Parties”), respectfully request a three (3) week extension for the comment deadlines on the July 1, 2013 *Administrative Law Judge’s Ruling Requesting Comments on Preliminary Staff Proposal to Clarify and Improve Confidentiality Rules for the Renewables Portfolio Standard Program* (“ALJ Ruling”). Currently, comments on the ALJ Ruling are due on July 29, 2013 and reply comments are due on August 20, 2013. The Joint Parties request that the comment schedule be extended by three weeks so that comments would be due on August 19, 2013 and reply comments would be due on September 10, 2013.

The Joint Parties believe that an extension is necessary to fully address the complex issues

raised in the ALJ Ruling. The ALJ Ruling proposes significant changes to the current confidentiality rules for the renewables portfolio standard (“RPS”) program and parties should be provided with sufficient time and opportunity to review and address the proposed revisions to the confidentiality protections. Furthermore, there are numerous regulatory deadlines that fall around the same time that comments are currently due. For example, in the RPS proceeding, reply comments on RPS procurement plans are due on July 22, 2013 and retail sellers are required to provide their RPS compliance reports on August 1, 2013. Moreover, retail sellers must report renewable energy credits retired for the 2011 reporting year to the California Energy Commission by July 29, 2013. Additionally, investor-owned utilities are required to submit an application regarding greenhouse gas costs and revenues of the Cap-and-Trade program on August 1, 2013. To ensure that the proper attention can be devoted to commenting on the ALJ Ruling, the comment deadlines should be extended to avoid the other regulatory deadlines described above.

For these reasons, a three week extension is appropriate as it avoids other regulatory deadlines in the RPS proceeding and will provide sufficient time to fully review, consider and address the significant proposed revisions to the RPS confidentiality rules. The requested extension should not delay any Commission actions or prejudice any party. In accordance with Rule 11.6, the Joint Parties emailed the service list on July 11, 2013 to determine whether any party objected to the requested extension. No party objected to the requested extension. In addition to the Joint Parties, the requested extension is supported by Jan Reid and Pilot Power Group, Inc. Furthermore, California Pacific Electric Company, LLC, and the Division of Ratepayer Advocates are not opposed to the extension.

The Joint Parties appreciate your consideration of this request.
