Extending Certain Filing Dates

NOTICE TO PARTIES IN I.12-01-007

This Administrative Law Judges' Ruling extends certain filing dates, as described below.

The July 30, 2013 *Administrative Law Judges' Ruling Requesting Additional Comment* (July 30 Ruling) provided that Pacific Gas and Electric Company (PG&E) should respond to questions in Section 3 thereof no later than August 14, 2013 and that all parties could file comments on questions in Section 4 by September 13, 2013 and reply comments by September 23, 2013. By e-mail ruling on August 13, 2013 we provided an additional five business days for reply comments, extending the filing date from September 23 to September 30, 2013.

The August 1, 2013 *Administrative Law Judges' Ruling Addressing July 18, 2013 Motion of Pacific Gas and Electric Company* revised the schedule for briefing in response to the Consumer Protection and Safety Division's (CPSD) Amended Reply Brief on Fines and Remedies, providing that PG&E's response shall be due on August 15, 2013 and that CPSD's and intervenors' rebuttal briefs shall be due on August 22, 2013.

On August 14, 2013, ALJ Wetzell authorized by telephone PG&E's requests for (1) an extension of the date for its response to Section 3 of the July 30 Ruling from August 14 to August 21, 2013 and (2) an extension of the date for its brief in response to the CPSD Amended Reply Brief on Fines and Remedies from August 15 to August 21, 2013. PG&E was directed to and did serve notice to parties of that telephonic authorization.

In order to preserve the intervals of time for responses, it is necessary to further revise the schedule for responses to the July 30 Ruling and the briefing schedule. Therefore,

IT IS RULED that:

1. The August 14, 2013 telephonic authorization is confirmed. The date for PG&E's response to Section 3 of the July 30, 2013 *Administrative Law Judges' Ruling Requesting Additional Comment* is extended from August 14 to August 21, 2013. The date for PG&E's brief in response to CPSD's Amended Reply Brief on Fines and Remedies is extended from August 15 to August 21, 2013.
2. The date for all parties to file comments in response to Section 4 of the *Administrative Law Judges' Ruling Requesting Additional Comment* is extended from September 13 to September 20, 2013.
3. The date for all parties to file reply comments as set forth in the *Administrative Law Judges' Ruling Requesting Additional Comment*, previously extended from September 23 to September 30, 2013, is further extended to October 7, 2013.
4. The date for CPSD and intervenors to file rebuttal briefs is extended from August 22 to August 28, 2013.
