Enclosed is Draft Resolution E-4555 of the Energy Division addressing Southern California Edison Company's advice letter (AL) 2784-E. It will be on the agenda at the next Commission meeting that is at least 30 days from the date of this letter, which is expected to be September 5, 2013. Comments may be submitted electronically.

Comments shall be limited to five pages in length plus a subject index listing the recommended changes to the Draft Resolution and an appendix setting forth the proposed findings and ordering paragraphs.

Comments shall focus on factual, legal or technical errors in the proposed Draft Resolution. Comments that merely reargue positions taken in the advice letter or protests will be accorded no weight and are not to be submitted.
