Enclosed is Draft Resolution E-4594 of the Energy Division addressing Pacific Gas and Electric Company's advice letter (AL) 4190-E. Comments shall focus on factual, legal or technical errors in the proposed Draft Resolution. Comments that merely reargue positions taken in the advice letter or protests will be accorded no weight and are not to be submitted.
