1. Assessment of Safety Considerations:

As stated in its Procurement Plan filed June 28th, 2013, Commercial Energy currently serves a small portion of the state's direct access (DA) load and expects that will not increase unless and until the legislature increases the amount of load that is eligible for DA service. Commercial Energy has met past procurement obligations through a mix of bundled and REConly transactions in compliance with the minimums and maximums allowed and/or required for the various categories, and plans to do the same to meet its future RPS obligations. Commercial Energy does not own or operate any renewable facilities, nor is Commercial Energy involved in any renewable facility project development.
