REQUEST FOR FIRST-TIME REPRESENTATIVE HOURLY RATE FOR RONALD LIEBERT

Explanation of request for hourly rate and summary of experience

Vote Solar requests a first-time representative hourly rate for Ronald Liebert, Vote Solar's external counsel and attorney for California regulatory matters, of \$395/hour for 2012 and 2013. Mr. Liebert has no previously adopted rate approved by the Commission.

Mr. Liebert has been practicing law as a member of the California Bar for nearly 24 years and has spent all of these years working as an Energy Regulatory Attorney representing various clients on a multitude of proceedings at the Commission, including approximately 20 major utility rate cases. Prior to becoming a member of the bar, Mr. Liebert worked for 5 years as an engineer specializing in energy-related design, construction and operational issues for power plants.

Over the past 24 years, Mr. Liebert has represented various clients, primarily customer groups, in many of the Commission's utility revenue and rate design applications (i.e., GRCs, ECACs, BCAPs, RDWs, Cost of Capital, etc.) as well as numerous other energy-related proceedings at the Commission, the Legislature, the California Energy Commission and local boards and agencies (including electricity industry restructuring, landfill gas/biogas regulation, natural gas storage, solar PV regulation and siting, environmental issues, etc). Mr. Liebert also served on the board of the California PX from its inception and for several years was the Chair of the CalPX's Legal/ADR committee.

Prior to returning to private practice with Ellison, Schneider & Harris in 2010, Mr. Liebert was an Associate Counsel for the non-profit California Farm Bureau Federation. For nearly 15 years, Mr. Liebert was the primary representative for California's agricultural customers' interests at the Commission, actively participating in nearly every Commission proceeding relevant to agriculture and agricultural customers.

Ellison, Schneider & Harris began assisting Vote Solar approximately one year ago. Mr. Liebert became Vote Solar's primary legal counsel for several Commission proceedings after the departure of Vote Solar's sole staff attorney, Ms. Kelly Foley.

Mr. Liebert's requested first-time representative hourly rate of \$395 for 2012 and 2013 is reasonable. It is less than the median authorized rate for attorneys with 13+ years of experience at the Commission and equal to or less than hourly rates authorized for other representatives with similar experience. For example, in 2010 and 2011, the Commission authorized an hourly rate of \$375 for Ann L. Trowbridge, which was increased to \$385 in 2012 (in Decision 13-02-019). For 2013, Ms. Trowbridge is seeking an hourly rate of \$400 (A.13-04-012, Agricultural Energy Consumers Association's Notice of Intent to Claim Intervenor Compensation, dated July 3, 2013). Since Mr. Liebert has been practicing as an Energy Regulatory Attorney longer than Ms.

Trowbridge and has more extensive experience before the Commission than Ms. Trowbridge, Mr. Liebert's requested first-time representative hourly rate of \$395 for 2012 and 2013 is reasonable.

Summary of Ronald Liebert's Relevant Experience before the Commission
