This is a courtesy notification to inform you that around 11:40 this morning, a contractor performing aerial patrol activities for PG&E in the Chico area crashed and caused a small fire. Unfortunately there were two fatalities, both involving the pilot and an observer on the plane. Wanted you to be aware in case the media contacted you. As I obtain more information, I will send along to you.

PG&E will be standing down on all aerial patrol activities for the next two days.
