Thanks for sharing the draft of your support letter. It looks good but the final sentence of the first paragraph is not technically correct: our group does not support the bill currently in print – but we do support the agreed upon amendments. If you want to submit the letter after the bill is modified to include our agreed upon amendments, that would be fine. To be crystal clear, I recommend that your letter be modified to either:

- 1) Remove the last sentence of the first paragraph, or
- 2) Clarify that we all support the bill with the forthcoming amendments.
