Dave,

In response to your question below, attached is a table of utility users' taxes in PG&E's service territory. As you can see, these utility users' taxes range from 0% for residential customers in San Francisco to 10% for customers in Firebaugh (small city off I-5 in the central valley). San Jose is 5%, Oakland is 7.5%, and Sacramento is 7.5%. In addition, there are also quite a variety of exemptions that are often customer- or bill-specific (e.g., caps, CARE, age, etc.). In addition to the utility users' tax, there is the Energy Commission tax, which is \$0.00029/kWh.

In order to get a better feel for these non-energy charges, I took a look at my last electric bill, which totaled \$23.31. My bundled electric charges (E-1 rate schedule) totaled \$21.63. The utility users' tax totaled \$1.62 and the Energy Commission tax totaled \$0.06, the sum of which was 7.2% of my total electric bill.

I would like to get a sense for what the maximum difference would be between the cost/kWh that you present on your website and the actual cost including all the charges that you exclude.

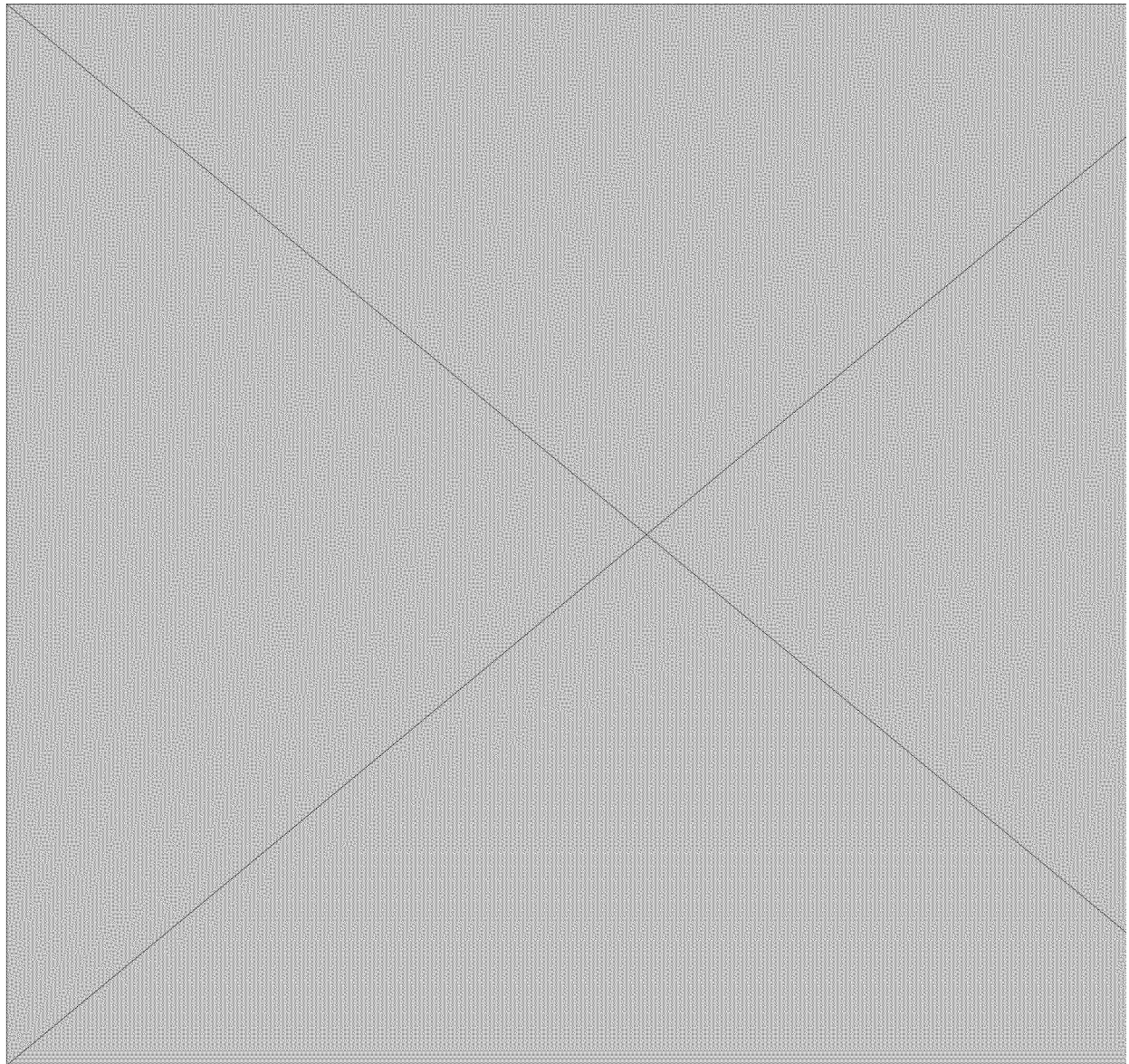
