**Subject:** RE: R. 11-02-019 Hearing Date for OSC Cross Examination

Dear ALJ Bushey:

SED respectfully requests that hearings for the Order to Show Cause be held after October 2, 2013. In light of PG&E's extensive new verbal direct testimony on September 6, 2013, SED must have an opportunity to present its own witness to clarify several issues that are fundamental to the Commission's decision about the appropriate MAOP on transmission lines along the San Francisco peninsula. SED proposes to have a witness prepare such written testimony. SED anticipates that PG&E would want an opportunity to rebut SED's testimony. Limited discovery may be necessary on PG&E's rebuttal.

SED makes this request with full cognizance that winter is coming and that PG&E has identified the possibility of curtailments on the peninsula. However, SED has weighed the issue of curtailment against what we now believe is a credible concern that some of PG&E's MAOPs may still be based upon inaccurate or incomplete records, and the fact that PG&E apparently still does not in every instance know the type of pipe that makes up the peninsula lines, which may violate the law or create an unsafe situation. For these reasons, we respectfully make this request.
