Subject: I.11-11-009 - PG&E Gas Pipeline Safety Investigations - Ruling Shortening Time

NOTICE TO PARTIES IN I.11-11-009

On September 9, 2013 the Division of Ratepayer Advocates and The Utility Reform Network (Joint Parties) served a motion (Joint Motion) to strike references to evidence outside the record contained in "Pacific Gas and Electric Company's Responses to Questions in Section 3 of Administrative Law Judges' July 30, 2013 Ruling Requesting Additional Comments" filed by Pacific Gas and Electric Company (PG&E) in these proceedings on August 21, 2013.

The Joint Parties request that the time to provide responses to the Joint Motion be shortened to Friday, September 13, 2013 so that a ruling can issue on the Joint Motion prior to the next round of comments due on Friday, September 20, 2013. In support of

their request for shortened time for responses, Joint Parties assert that “[a]n early ruling would obviate the need for parties to respond to PG&E’s extra-record factual assertions and would hopefully discourage such assertions in future pleadings.” Joint Motion at 3.

We will shorten the time for responses to enable issuance of a ruling on the Joint Motion prior to September 20, 2013. In the interest of time, we issue this ruling with the assumption that the Joint Motion will be accepted for filing by the Commission’s Docket Office.

IT IS RULED that responses to the Joint Motion are due on September 13, 2013.

Administrative Law Judges Yip-Kikugawa and Wetzell
