Assuming that the CAISO posts updated model results by Tuesday September 17, this would allow DRA adequate time to re-run its Track 2 scenarios with the revised assumptions.

Given the amount of time between the deadline for submission of studies and the deadline for parties to reply to the studies, DRA would not request an extension of the November 1 deadline for parties to reply to opening studies, but it would not oppose such an extension.
