All of the GT&S Safety Reports are posted in Webdocs as part of the 2011 GT&S Proceeding and are publicly available through the PG&E website under the "Media Newsroom" hyperlink. Unfortunately, it's not very user friendly unless one is familiar with navigating through to get to the Regulatory Cases. Anyway, here's the link to the 2011 GT&S Rate Case files. Once here, it's still a matter of filtering/sorting to find the safety reports amongst the other documents, but at least it'll point Terrie to one location to look for them. If he's looking for individual links to each report, I suggest you ask [Redacted] to help with this.
