PG&E filed advice letters 4160-E and 4161-E on December 10, 2012. 4160-E requests termination of our PV program. 4161-E requests authorization to move the remaining 252 MW from the PV program into RAM. I understand that these advice filings are being held up because of a disagreement between Energy Division and the ALJ division over whether or not it is appropriate to make these program changes by advice filing. D.10-04-052 authorizes PG&E to terminate the PV program by advice filing and we were advised by your staff almost one year ago to make this request by advice letter.
