Subject: R.13-02-019 - Assigned ALJ Ruling regarding due date for protest and receipt of attached documents into the record of this proceeding

Good afternoon. On October 18, 2013, the California Department of Water Resources (DWR) submitted to the Commission its “Revision to the Determination of Revenue Requirement For the Period January 1, 2014 through December 31, 2014” (revised 2014 revenue requirement determination), its “Notice of Determination of Revenue Requirements” (Notice) dated October 18, 2013, and a memorandum dated October 18, 2013 to President Peevey from DWR’s Acting Deputy Director, John Pacheco. DWR requests in the memorandum “that the Commission calculate, revise and impose Bond Charges...” and “that the Commission calculate, revise and impose Power Charges...” based on the revised 2014 revenue requirement determination (see attached).

This revised 2014 revenue requirement determination: 1) updates and replaces the earlier determination that was submitted to the Commission on August 1, 2013; and 2) will be used as the basis for the

Commission’s allocation of DWR’s costs to these customers.

Accordingly, I rule that the attached DWR Notice, revised 2014 revenue requirement determination, and October 18, 2013 memorandum are included in the record of this proceeding.

I also rule that any protest to the attached revised 2014 revenue requirement determination shall be filed with the Commission’s Docket Office and served on the service list of R.13-02-019 by October 24, 2013.

My rulings herein will be memorialized in hard copy at a later date.
