Eugene,

I hope all is well with you. It has been sometime since we worked on a project together. Karen Boven forwarded me some questions you have regarding Stanpac.

1) Overview/History of Stanpac:

- [Redacted] Originally built as a 127 mile 26" pipeline running from Kettleman Hills to Richmond
- [Redacted] Owned by a non-profit entity providing service to the member entities in accordance with their ownership interest
- [Redacted] The Stanpac pipeline entered service in 1931
- [Redacted] On formation Stanpac was equally owned by PG&E and Chevron
- [Redacted] Over the years, PG&E has acquired parts of the Stanpac pipeline and has increased its membership interest
- [Redacted] Today Stanpac owns the pipeline running from Rio Vista to Richmond about 52 miles
- [Redacted] Stanpac is owned 6/7 by PG&E and 1/7 by Chevron

2) Service Tariff

- Stanpac does not serve any customers directly and has no revenue or tariffs

3) System Map, volumes, customers

- An overview system map (attached)
- Volumes in the line are not metered
- The line operates as an integral part of the PG&E system

4) Organization Chart

- Stanpac has no employees
- PG&E is the operator of the line
- The Stanpac board has 3 members from PG&E and one member from Chevron

5) Headquarters

- 77 Beale Street

6) Stanpac employees

- Stanpac has no employees
- PG&E operates the line for Stanpac, as such numerous PG&E employees do work for Stanpac which is charge to Stanpac
- Each owner pays the general cost of operations in proportion to their ownership
- Chevron or PG&E may pay 100% of the cost of new facilities that only provide benefit to one company
