TO OPEN ISSUE PUBLIC PARTICIPATION HEARING,

SAN FRANCISCO, Oct. 1, 2013 - The California Public Utilities Commission (CPUC) will hold a community Open Issue Public Participation Hearing, Resource Fair, and Voting Meeting in Redding, Calif., in October to reach out to consumers.

**Open Issue Public Participation Hearing**

The CPUC will hold an Open Issue Public Participation Hearing with all Commissioners in attendance to offer the public an opportunity to provide comments to the Commissioners on any issue under CPUC jurisdiction.

**WHEN:** Oct. 16, 2013, 4 p.m. – 6 p.m.

**WHERE:** Redding City Hall, Community Room and Council Chambers, 777 Cypress Ave., Redding

Those who provide comment at the Open Issue Public Participation Hearing will not be allowed to repeat their comments during the Public Comment Session at the Voting Meeting, on Oct. 17, 2013. While a quorum of Commissioners and/or their staff may attend the Open Issue Public Participation Hearing, no official action will be taken.

**Resource Fair**

At the CPUC's Resource Fair, community groups and utilities will provide information and assistance on programs such as California Alternate Rates for Energy (CARE), California LifeLine, telephone equipment for people with disabilities, bill issues, and more. In addition, the CPUC will have staff on hand to assist consumers with utility company complaints.
