I write on behalf of SED, DRA, TURN, the City of San Bruno and PG&E to report on our meet and confer concerning the continued hearing schedule. We conferred on Monday, September

30, and Wednesday, October 2, and agreed on the following proposed schedule:

October 14	PG&E finishes responding to all currently outstanding discovery except the two most recent sets of DRs from DRA and the most recent set from SED
October 22	PG&E finishes responding to the balance of currently outstanding DRs
November 1	SED serves testimony
November 5	PG&E serves DRs on SED testimony
November 12	SED serves responses to PG&E DRs
November 18	PG&E serves rebuttal testimony
November 20	Parties serve DRs on PG&E's rebuttal testimony
December 3	PG&E serves responses to DRs
December 6 & 9	Continued evidentiary hearing
OR	
Two days in the week of December 9	

Although PG&E previously raised a question about the scope of the data requests it has received, with the exception of one DR that we and DRA agreed to narrow, PG&E is responding to all DRs as propounded.

The proposed schedule assumes that Your Honor grants SED's request to present a witness and takes account of the time involved in responding to DRs, the schedules of PG&E's witnesses and counsel, and the Thanksgiving holiday. The parties anticipate that two additional days of hearings will be necessary.
