Subject: I.12-01-007, I.11-02-016 and I.11-11-009 (Pipeline OIIs) - Ruling Addressing
DRA/TURN Motion to Strike

NOTICE TO ALL PARTIES IN I.11-02-016:

On October 3, 2013, the Division of Ratepayer Advocates and The Utility Reform Network (Joint

Parties) filed a motion to strike certain portions of Pacific Gas and Electric Company's (PG&E's) September 20, 2013 filing. PG&E's filing was in response to our July 30, 2013 ruling seeking additional comment related to the fines and disallowances at issue in the Pipeline Investigations (I.11-02-016, I.11-11-009 and I.12-01-007). Joint Parties contend that PG&E's comments in response to questions posed in Section 4 of our July 30 ruling contain new evidence and new arguments or present arguments that could have been made in previous briefs. Therefore, Joint Parties move to strike all non-responsive information contained in PG&E's response. Joint Parties further request that the time to respond to its motion be shortened, and that the date for filing responses to the Section 4 Comments be extended.

In order for us to address Joint Parties' motion expeditiously, we shall shorten the time for parties to respond to Joint Parties' motion to Monday, October 7, 2013. Additionally, we extend the date for parties to file their replies to the comments in response to the Section 4 questions from October 7, 2013 to October 15, 2013.

IT IS RULED that:

1. Responses to the Joint Motion of the Division of Ratepayer Advocates and The Utility Reform Network to Strike all Non-Responsive Information Contained in Pacific Gas and Electric Company's Response to Section 4 of Administrative Law Judges July 30, 2013 Ruling Requesting Additional Comment and to Shorten Time for Responses shall be due on October 7, 2013.
2. The date for parties to file reply briefs to the comments in response to the Section 4 questions is extended to October 15, 2013.
