Pursuant to Rule 11.1 and 11.4 of the California Public Utilities Commission's ("Commission") Rules of Practice and Procedure ("Commission Rules"), the City of San Carlos ("San Carlos") respectfully files this Motion of the City of San Carlos to File Under Seal the Confidential Version of Exhibit A Attached to its Motion for an Order Directing PG&E to Maintain Reduced Pressure on Natural Gas Pipeline 147 and to Compensate the City of San Carlos for all its Costs Associated with Participation in R.11-02-019 (the "Motion"). San Carlos moves the Commission for an order granting leave to file the confidential version of Exhibit A attached to the Motion under seal.

To support the Motion, San Carlos attached intra-utility emails provided by PG&E as Exhibit A (the "PG&E Emails"). Names of PG&E employees have been redacted from the PG&E Emails to comply with a confidentiality agreement, although these same emails were produced in this proceeding by PG&E in this form. Additionally, two sections of the PG&E

Emails have been redacted by PG&E that referenced the thickness of the Natural Gas Pipeline 147.

For the foregoing reasons, San Carlos respectfully moves the Commission for an order directing that the confidential information appearing in Exhibit A to San Carlos' Motion shall be placed under seal and shall not be made accessible or disclosed to anyone other than the Commission.
