- 1. Confirmed that current slide-deck presentation met expectations going forward.
- 2. Established the need for PG&E to provide an update on Leak Survey activities as well as progress on the Community Outreach effort.
- 3. Agreed to the (4) components of this overall plan:
  - L-114 Specific Actions
- Extent of Conditions for TCI Vendor
- NDE Enhancements
- Extent of Conditions for all applicable welds Post 1961
- 4. Agreed that PG&E will work to base mitigation efforts on a Risk Based Plan (Class Location, Leak History, Pressure, etc.) 5. Discussed a potential plan to reduce the amount of Leak Survey mileage. Further discussion would be needed, but the thought was that if PG&E could show a line to have other safety mitigation efforts done on it (ILI, HydroTest, not susceptible to ground movement, automated valves installed, etc.), that the Leak Survey may become unnecessary.
- 6. Agreed to the L-114 Final Report being completed no later than 12/6/13.
