Good morning --

Wanted you all to know that colder weather and higher demand for gas necessitate operation of Line 147 in San Carlos at the 125 psig pressure level that ALJ Bushey allowed for as part of the discussion at the October 21 prehearing conference. We notified SED via the email below last night.

(The 125 psig level is the reduced pressure from the previous 300 psig operation.)

Customers in the area and the City of San Carlos will be notified of this change.

PG&E is providing this courtesy notification regarding the need to operate L-147 due to forecasted cold weather conditions on the

Peninsula in order to serve the City of San Carlos. PG&E will be completing the installation of regulation for L-147 at the Edgewood station and is planning to start operation of L-147 on November 27, 2013. As you are aware, L-147 is currently static, but is pressurized to 125 psig. The installation of the regulation will allow safe operation of the line without the need to manually control the pressure.

PG&E's will operate L-147 at that same pressure of 125 psig as agreed upon during the October 21, 2013 L-147 prehearing conference with ALJ Bushey. Following this notification to SED, PG&E will also provide notification to the customers in the area as well making them aware of our plans to operate this line.
