Brian Daubin began to review slide deck with Terence Eng:

Brian Daubin submitted final L-114 Report.

- SED now considers concerns with L-114 mitigated and all concerns resolved for that segment of pipe

PG&E has identified 600 miles of pipe to Leak Survey

- Terence requested the need to provide Leak Survey results as soon as they become available for 600 miles of pipeline segments
- Brian Daubin committed to providing results as they come available

Went through the description of AGFA Film quality. Established that the lower the AGFA "D" number the higher the film quality

- Terence Eng requested answer as to why WIX (NDE Contractor) is using D7 film for TCI re-inspections, instead of D5 which is now PG&E's requirement in their Technical Specification.
- Brian Daubin to provide follow up

Brian Daubin to follow-up on TD-4160M. Terence never received CD from PG&E

Terence Eng requested a list of the 3755 identified Welds and the 488 welds ATS did comprehensive review on

Terence Eng communicated that SED is looking to have BV do a 3rd Party Review of 3755 Welds (film).

- Would like to do a random sampling of total population (3755)
- Concerned that comprehensive review was only done on 488
- Sometime in January, should take 2 weeks.
