**RE: Request for Extension for Submission of the Final 20% RPS
Program Closing Reports in Compliance with Decision 12-06-038**

Dear Mr. Mathai-Jackson:

This is in response to Pacific Gas and Electric Company's ("PG&E"), Southern California Edison Company's ("SCE"), and San Diego Gas & Electric Company's ("SDG&E") (collectively, the "Joint IOUs") December 5, 2013 electronic mail request for extension of the due date for the Final Closing Report for the years prior to 2011 of the renewables portfolio standard (RPS) program. Pursuant to Rule 16.6 of the Commission's Rules of Practice and Procedure, the Joint IOUs requested an extension of time to comply with the time for submitting the report that was set in Decision (D.) 12-06-038.

Pursuant to D. 12-06-038, retail sellers must file and serve Final RPS Closing Reports for the years prior to 2011 within 30 days after the California Energy Commission (CEC) transmits its RPS Verification Report to this Commission. For the purpose of initiating the 30-day time period, D. 12-06-038 may be understood to mean that the date of transmittal of the CEC's final Verification Report is the date the CEC publishes its "notice of availability" of the report. The CEC published its notice of availability on Friday, November 22, 2013; thus, the submission date for the Final RPS Closing Report is Monday, December 23, 2013. The Joint IOUs request an extension to January 23, 2014 to submit their Final RPS Closing Reports.

There is no known opposition to the Joint IOUs' request. The request is granted and the extended due date applies to all retail sellers. All Final RPS Closing Reports are now due to Energy Division not later than January 23, 2014. The Joint IOUs must promptly


