PLEASE TAKE NOTICE THAT on December 19, 2013, Pacific Gas and Electric Company (PG&E) filed "Application of PG&E Proposing Cost of Service and Rates for Gas Transmission and Storage Services for the Period 2015-2017."

The Application requests that the California Public Utilities Commission (Commission or "CPUC") increase PG&E's gas transmission and storage rates, effective January 1, 2015, to collect the revenue requirements necessary for PG&E to continue to provide safe and reliable service to its customers.
