Subject: R.12-03-014: Letters of support for continued collaboration

Dear Parties to Proceeding R.12-03-014,

Attached are two letters which support continued collaboration between the California Energy Commission (CEC), California Independent System Operator (CAISO), and California Public Utilities Commission (CPUC) in establishing common assumptions to be used in long-term resource planning.

These were submitted to the CPUC by the CEC and CAISO, respectively. They affirm that the two-phase biennial structure for the Long-Term Procurement Plan (LTPP) proceeding - as described in the Order Instituting Rulemaking proposed for adoption by the CPUC today - will align well with the CEC's Integrated Energy Policy Report (IEPR) proceeding and the CAISO's annual transmission planning process (TPP). This alignment will improve coordination of decision timing across the State's generation and transmission planning

processes, specifically the 2014 LTPP and 2014-2015 TPP.

In their respective letters, the CEC and CAISO detail the roles they will play in this inter-agency process alignment.

On behalf of the CPUC, we welcome this continued effort between our agencies.
